Member Tebon asked about the Diggers Hotline payment, Administrator Willis explained that the Village must prepay for the Diggers Hotline services and that the requests that come in then are deducted from the prepaid balance. Member Tebon then stated the rest looked pretty straight forward, which included the release of property taxes that were collected for other taxing authorities.

Administrator Willis explained the application was complete with background check and signed off by Deputy Deputies with the Learn-2-Serve certificate attached and he saw no reason not to recommend approval.

d. Recommendation on issuance of a Class"B" Beer and Liquor Combination for the period of January 23, 2024 – June 30, 2024 Deerfield Grille LLC c/o Bret Clostermery located at 15 N Main St, Deerfield, WI 53531.

Administrator Willis explained the application is included in the packet, learn-2-serve certificate, and a diagram of the premise. Mr. Willis also let the members know that the applicant was attending and asked if the applicant wanted to give the Committee a rundown of what the plan for the new business will be. Applicant Bret Clostermery addressed the Committee and thanked them for the opportunity to review his application. Mr. Clostermery described the intent of their new business, Deerfield Grille, is to make it a comfort food restaurant/bar. He explained tentative hours of operations and said they are hoping to capture the breakfast crowds on Saturday/Sunday and will be opening at 8 AM, but closed on Mondays. The manager has over 30 years of experience in the field and was a native to Deerfield in her younger years. Mr. Clostermery mentioned he is aware of certain standards, specifically listing the dumpster enclosure, that the Village will have for the new business. He also discussed some of the updates he will be hoping to bring to the building façade and the patio/deck area. Mr. Clostermery also shared how they hope to be a good community member and mentioned their menu item of a spicy jalapeño burger named the Demon burger, that would share a portion of its profits back to the community. Member Tebon asked the timeframe in which he hoped to be open and Mr. Clostermery explained they are moving forward very aggressively and their current limitation, after the meeting tonight, was some equipment which would push them back to about February 13th. Mr. Clostermery did mention that they will be working on bringing tap beer back, but that there is additional work to be done on the system before that can occur.


